Dog and Kennel License Fees

Fees Required for Initial License or Renewal

- For one spayed or neutered dog\$ 20.00/ea
- For one dog (male/female)\$ 30.00/ea

Licensee Fee for Each Additional Dog

- For a second dog \$ 30.00
- For a third dog \$ 50.00
- For a fourth or more dogs \$100.00

Kennel License Fees (Prior Approval Required)

- A kennel of Pure-bred dogs \$ 35.00
- A kennel of Working or Sporting dogs \$ 50.00
- A Boarding kennel \$ 50.00

Dogs offer companionship and security. In return, dog owners have responsibilities to their pets and to their communities.



By-law No. 2004-57, as amended outlines requirements for the licensing, regulating and control of dogs within our municipality. The Council for the Corporation of the Township of Severn has determined that a more pro-active approach to dog control must be initiated. This serves as a **“Notice of Zero Tolerance”** respecting non-compliance to By-law No. 2004-57, as amended.

***Owners are required to license their dog(s)
on or before March 31, 2010.***

Failure to license and control your dog(s) is an offence which is subject to a fine.

Licensing & Regulating of Dogs & Kennels By-law No. 2004-57, as amended

1.	Fail to register and license a dog within the Township of Severn	Section 2	\$ 55.00
2.	Fail to keep a dog tag securely fixed to the dog	Section 4	\$ 55.00
3.	Use a dog tag for a dog other than to which it was issued	Section 4	\$ 55.00
4.	Allow a dog to run at large	Section 8.2	\$ 105.00
5.	Allow a dog to howl or bark excessively or otherwise become a nuisance	Section 8.4	\$ 105.00

NOTE: The penalty provision for the offences indicated above is Section 10 of By-law No. 2004-57, as amended, enacted Severn Township Council, in accordance with the Municipal Act, S.O. 2001, Chapter 25, a certified copy of which has been filed.
