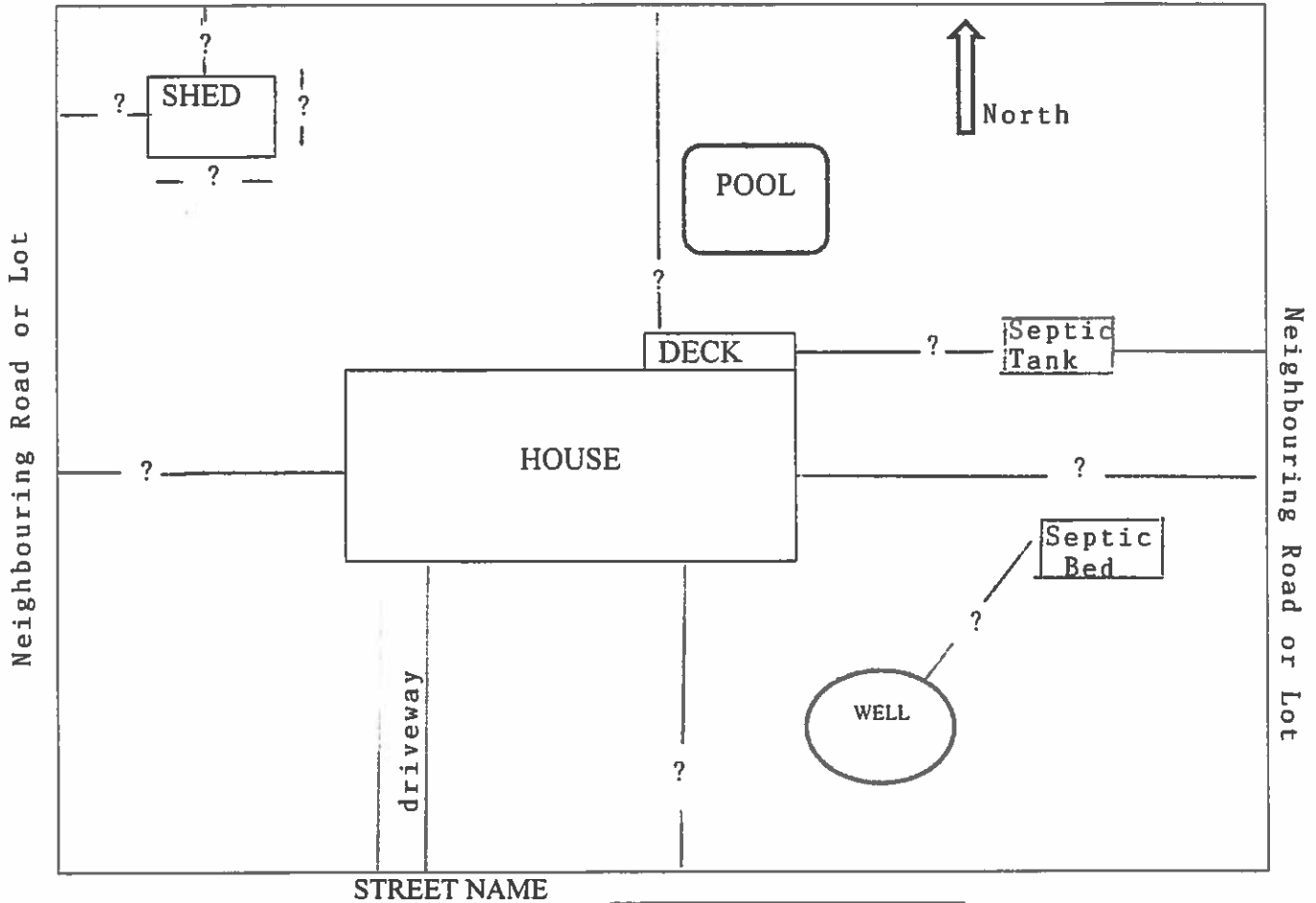

Schedule 1 is also not required to be completed by a holder of a license to practise, a limited license to practise, or a certificate of authorization, issued by the Association of Professional Engineers of Ontario.

Site Plan must display:

- All existing and proposed structure(s)
- Setbacks (distances) from property boundaries to current and/or proposed structure(s) shown in feet or metres (red ink)
- Dimensions of structures
- Septic system and well (specify if dug or drilled)
- Setbacks from septic to well and septic to structures
- Driveway
- North arrow
- Street Name(s)
- Neighbouring lots or roads
- Natural features: streams, rock, wooded areas, steep slopes, etc.
- It is important that you provide an accurate and complete Site Plan with your application or it can be returned to you as incomplete or delayed.
