## WAIVER OF LIABILITY

You agree to same harmless and keep indemnified the Washago Community Centre, and its organizers, members, directors, agents, officials, servants, volunteers, and representatives:

- (a) from and against all claims, actions, costs, expenses, and demands in respect to injuries, death, loss or damage to any person or property howsoever caused, arising out of or in connection with your involvement and/or participation in the Parade;
- (b) from any and all liabilities, damages, costs, suits and actions brought by third parties whatsoever resulting from your involvement and/or participation in the Parade; and notwithstanding that the same may have been contributed to or be occasioned by the negligence of the Washago Community Centre, and its organizers, members, directors, agents, officials, servants, volunteers, and representatives

You also agree:

- (a) to reimburse the Washago Community Centre for any loss or damage of property arising out of Your participation in the Parade, howsoever caused.
- (b) that this Waiver of Liability may be pleaded in any proceedings in any court and shall act as an estoppel against You in any action commenced by You.

You understand and agree that this Waiver of Liability is binding on You, Your heirs, executors, assigns and legal representatives.
